

Privacy declaration - Bassin Student Housing

01. Introduction

This Privacy Statement relates to the processing of personal data of visitors to the website <https://bassin.nl/> van MVJ Ludigibo B.V.. We, MVJ Ludigibo B.V., respect the privacy of visitors to our website and handle your personal data with care. In doing so, we adhere to existing privacy laws and regulations.

In this Privacy Statement we inform you about the way in which we process your personal data.

02. For what purpose are the data processed and which personal data are processed?

We may process personal data of visitors to our website (hereinafter: visitors) for one or more of the following purposes:

- sending newsletters;
- dealing with questions;
- processing service requests;

We process from all our visitors:

Cookies.

In addition, you have the choice to leave personal data yourself via our website, for one of the aforementioned purposes.

We only process personal data that you leave with us yourself:

- Name
- Address details
- E-mail address
- Phone number
- Gender
- Date of birth
- Birthplace
- Education
- Educational institution
- Schoolyear

03. How are the personal data collected?

Visitors' personal data is obtained in the following ways:

- Through the use of the website as well as the cookies placed on it;
- By providing personal data by the user himself.

04. How are the personal data secured?

We take the protection of the personal data of visitors to our website seriously and therefore take appropriate organizational and technical measures to prevent abuse, loss, unauthorized access, unwanted disclosure, unauthorized modification or otherwise unlawful processing.

Our employees who have access to your personal data only have access to this personal data if necessary for the performance of their function and / or to support the website.

05. What rights do visitors have and how can they exercise them?

Under the General Data Protection Regulation, visitors have various rights with regard to their personal data to ensure their privacy:

- Right of inspection;
- Right to correction / addition;
- Right to erasure;
- Right to restrict processing;
- Right to transferability;
- Right to object to processing.

To ensure that the request has been made by you, we request that you include a copy of your ID with the request. To protect your privacy, we ask you to black out your passport photo and citizen service number (BSN) in this copy.

When we receive a request, depending on the nature of the request, we will first weigh up the interests and assess whether we can and may comply with the request. Then we will send an appropriate response.

You also always have the right to lodge an objection with the Dutch Data Protection Authority or to start a procedure with the court.

06. Provision of personal data to third parties

We can share visitors' personal data with:

- Partners, clients or customers of MVJ Ludigibo B.V.;
- Service providers who are engaged on behalf of MVJ Ludigibo B.V. provide services;
- Third parties, including but not limited to regulators, the tax authorities or other authorities to comply with legal obligations.

We conclude a processor agreement with third parties who process personal data on our behalf to ensure an adequate level of security and confidentiality of our visitors' personal data.

07. Retention period

We do not store visitors' personal data longer than necessary for the purposes for which they were obtained, unless we are legally obliged to keep data longer.

08. Cookies

Our website does use cookies. Usage data may be used at a later time to improve website performance. The usage data used for this is anonymized.

09. Links to third party websites

Our website may contain references and / or hyperlinks to one or more third-party websites. We are in no way liable for the way in which these third parties deal with privacy legislation. We advise those involved to consult the privacy statements of the websites of these third parties to be informed about the ways in which these third parties handle their personal data.
